The market value of the portfolio represents prices quoted on overseas stock markets in foreign currencies converted to Australian currency. The rate used for conversion of values of US currency securities was USD 1.07095 (last month USD 1.09845).

The NTA excludes deferred tax assets which include unrealised losses in the portfolio of investments. The deferred tax assets at 31 August 2011 potentially reduce future tax liabilities by 15.3 cents per share.
