Templeton Global Growth Fund Ltd is a long term investor and is not intending to dispose of its total portfolio of investments.

The market value of the portfolio represents prices quoted on overseas stock markets in foreign currencies converted to Australian currency. The rate used for conversion of values of US currency securities was USD 0.96825 (last month USD 0.89005).

The NTA excludes deferred tax assets which include unrealized losses in the portfolio of investments. The deferred tax assets at 30 September 2010 potentially reduce future tax liabilities by 12.8 cents per share.
