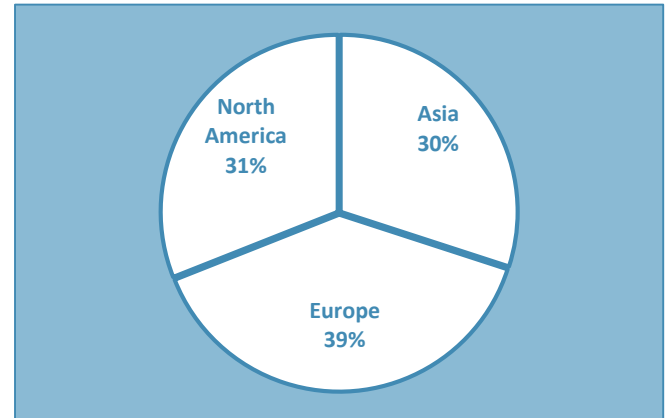

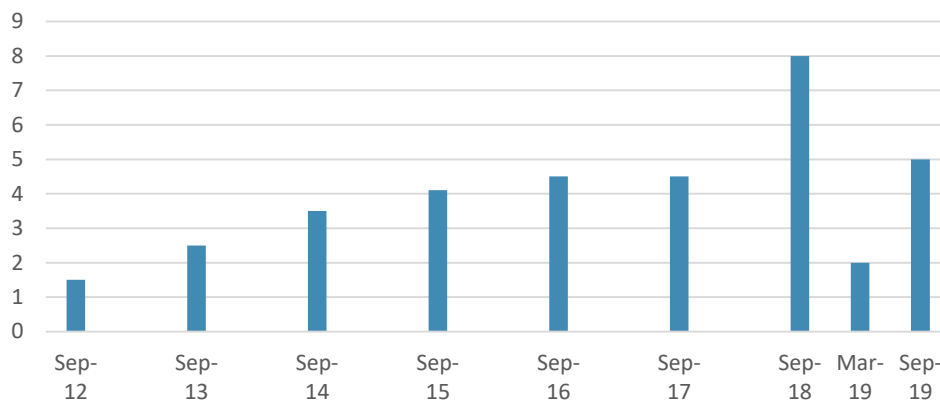
## Regional Allocation
